All ticket prices for all events are stated in U.S. Dollars.

## **2. Payment Methods**

## **3. Who You Are Buying From**

We are the “Event Organizer”. Tickets that are obtained from unauthorized sources, and not directly through our Site are void. Tickets are sold under the name and email address of the purchaser and unique to that individual. Ticket sales are non-transferrable. Ticket resales or ‘gifting’ is not allowed. If you wish to purchase a ticket on behalf of another party, contact [support@masculineexcellence.com](mailto:support@masculineexcellence.com).

## 4. Pricing and Availability

Tickets sold by the Event Organizer are distributed on a first come, first served basis. Availability is determined by the Event Organizer and can be updated or changed at any time. The number of tickets are limited due to the venue size.

Ticket returns are Prohibited. Ticket Resales are Prohibited. Tickets are Non-Transferrable.

Pricing is determined by the Event Organizer and includes only what is outlined on the ticket sales page. Any changes or updates to ticket inclusions will be communicated directly to ticket holders.

Further, with respect to resale tickets purchased from the Site: Market prices are subject to change at any time prior to Order Confirmation, and we do not guarantee that you will be able to purchase the tickets for the prices shown on our Site, or that such tickets will be available, until Ticket Confirmation. We are not responsible for any typographical or system errors within the inventory listed for sale. If an error is found while processing your order, you will be notified of the error and a substitution will be made when available, at no additional cost. Please check your tickets carefully once confirmed and please contact us if you have any questions regarding the tickets or access you received.

## 5. Order Confirmation and Processing

All ticket sales must be approved by Donovan. Your ID must be confirmed. The Event Organizer retains the right to refuse ticket sales to anyone, for any reason. Media/Press is strictly prohibited. All ticket sales are considered PENDING until the ticket has been CONFIRMED.

Before a ticket is purchased, you must agree to the Terms of Service, the Code of Conduct, and the return Policy.

**PENDING** TICKET Status: Your ticket is considered bought however still PENDING once purchased. You must have your information reviewed by Donovan personally and get on a Zoom call where you will present your ID which matches your payment

information. Once these steps are complete, your photo will be assigned to your ticket. Your ticket will then be Confirmed and payment processed.

The PENDING process can take up to one week. If you are unable to confirm your ticket, or your confirmation is denied for any reason, your ticket hold will be released and your payment will be refused. You will NOT be able to re-purchase a PENDING ticket. Future attempts to purchase will be rejected.

#### **CONFIRMED TICKET Status:**

Your ticket is confirmed when we send you a confirmation, in the form of an email ("Ticket Confirmation"). Once your ticket is confirmed you will receive further instruction to access the Event App and attendee only information.

If your ticket is REFUSED, you will receive an email with a brief explanation and information regarding your payment refusal.

If you have not heard from us, or have only received a confirmation that we received your ticket request, please contact us to check on your order. NEVER make an assumption about the status of your order because you have not been contacted by us. Orders cannot be canceled due to problems with receipt of emails or text messages.

## **6. Service Fees, Order Processing Fees, Taxes, and Shipping Charges**

Tickets purchased on our Site are not subject to service, order processing, confirmation, taxes or shipping charges due to the nature of the "e-ticket" environment. Your physical ticket will come in the form of a badge and code issued at the physical event registration desk.

## **7. Number of Tickets or "Ticket Limits"**

Ticket limits are set due to COVID-19 capacity restrictions and facility capacity. VIP tickets are limited due to quality of the experience and special access capacity.

## **8. Ticket Transfer**

Ticket sales are non-transferrable. Ticket resales or 'gifting' is not allowed. If you wish to purchase a ticket on behalf of another party, contact [support@masculineexcellence.com](mailto:support@masculineexcellence.com) for special case by case basis review.

## **9. Factors Due to COVID-19**

Due to the impact of the global COVID-19 pandemic, the scheduling of events for which you have purchased tickets may be affected. The Event Organizer is not responsible for restrictions or guidelines that may affect your travel. All attendees must follow federal and state mandates while in attendance related to COVID-19. Attendees showing signs of illness, fever, or COVID 19 symptoms may be denied entrance at any time by the event or venue staff.

## **10. Canceled, Postponed, Rescheduled, and Moved Events**

Occasionally, events are canceled, postponed, rescheduled to a different date or materially different time, or moved to a different venue:

If the event is canceled: no ticket returns/refunds will be provided, however, your ticket will be good for a similar event at a future date. The Event Organizer is not responsible for losses or expenses due to travel or lodging in the event of a cancellation, rescheduling, or venue move.

If the event is postponed, rescheduled, or moved: your ticket(s) (including any additional add-ons or upgrades) are still valid, and no further action is required.

If your event is canceled, postponed, rescheduled, or moved, we will attempt to contact you to update you on the status of the event, and instructions to proceed. For exact instructions on any particular canceled, postponed, rescheduled, or moved event, please check the event information online and in the app (which you will have access to upon Ticket Confirmation).

We will not be liable for travel or any other expenses that you or anyone else incurs in connection to the event.

## **11. Ticket Returns, Credits, and Exchanges**

All sales are final. If in the rare case a ticket return is accepted by the administration, it will be processed to the original method of payment used at time of purchase. We cannot issue a return to a different credit or debit card. There are no exceptions. If the account is closed for any reason the card holder must take it upon themselves to resolve the issue with their card issuing bank.

**Credits.** The Event Organizer will provide a future event credit in the case of canceled, postponed, rescheduled, or moved events; we will send you a notification via email. Credits cannot be used for resale tickets. The Event Organizer will determine which future events, venues, and ancillary purchases are eligible, as well as the amount of the credit (including any potential promotional amount). The amount of the credit will always include at least 100% of the price of the original ticket(s), plus fees and taxes. The amount of the credit will include any additional add-ons or upgrades included in your original purchase. Once we've verified your order is eligible for credit, we'll send you a credit code which you can use for eligible purchases, along with instructions for redeeming that credit. Please note that credits do not have an expiration date. Credits are non-transferable, may not be sold, are not redeemable for cash, and may not be combined with other promotions.

**Merchandise.** All merchandise purchases are final, and in no event will there be returns, exchanges, or credits for merchandise purchases.

**Chargebacks and Other Return/Refund Prohibitions.** You agree that you will not attempt to evade, avoid, or circumvent any policies in any manner with regard to tickets you purchased. Without limiting the generality of the foregoing, you will not contact us to seek a refund, return or exchange from us and you will not dispute or otherwise seek a "chargeback" from the company whose credit card or other method of payment you used to purchase tickets from the Site. Should you do so, your tickets are subject to immediate cancelation, and we may, in our sole discretion, refuse to honor pending and future ticket purchases made from all credit card accounts or online accounts on which such chargebacks have been made, and may

prohibit future purchases from all persons in whose name the credit card accounts exist, and from any person who accesses any associated online account or credit card or who otherwise breaches this provision from using the Site.

## **12. Account, Order, and Billing Information Verification**

All information on accounts and orders must be valid and are subject to verification.

Ticket purchases are PENDING until CONFIRMED and subject to ID confirmation, billing information confirmation, credit card approval, and are processed only after the billing address associated with your credit card and other billing information have been verified. Orders that are placed, or attempted to be placed, using an account with any information that is found to be false, misleading, incorrect, or incomplete, or that cannot be verified as belonging to the account holder—such as name, address, email address, phone number, IP address, or other account or billing information—are subject to cancelation without refund, at any time. Furthermore, if your order is canceled for any of the foregoing reasons, we may sell your tickets to another customer without further notice.

## **13. Delivery Options**

Ticket confirmation is via Email and Text Message (SMS).

## **14. Limitation of Liability**

You voluntarily assume all risks and danger incidental to the event for which the ticket is issued, whether occurring before, during or after the event, and you waive any claims for personal injury or death against us, management, facilities, speakers, leagues, artists, other participants, and all of our respective parents, affiliated entities, agents, officers, directors, owners, and employees on behalf of yourself and any accompanying minor. You bear all risks of inclement weather. Event date and



time are subject to change. We assume the responsibility of reasonable security for all events.

You assume all risks, hazards, and dangers arising from or relating in any way to the risk of contracting a communicable disease or illness—including, without limitation, exposure to COVID-19 or any other bacteria, virus, or other pathogen capable of causing a communicable disease or illness, whether that exposure occurs before, during, or after the event, and regardless of how caused or contracted—and you hereby waive any and all claims and potential claims against the Event Organizer relating to such risks, hazards, and dangers.

## **15. License; Ejection and Cancellation; No Redemption Value**

You agree to comply with all of the Event Organizer's applicable rules, code of conduct, policies, terms, and conditions ("Event Organizer Rules"). The Event Organizer reserves the right, without return of any amount paid, to refuse admission to, or eject, any person whose conduct management deems disorderly, who uses vulgar or abusive language, or who fails to comply with Event Organizer Rules. Breach of terms or rules will terminate your license to attend the event without return. A ticket is a revocable license and admission may be refused. A ticket is not redeemable for cash.

## **16. Recording, Transmission and Exhibition**

You agree that the event for which you purchase tickets is a public event, that your appearance and actions inside and outside the venue where the event occurs are public in nature, and that you have no expectation of privacy with regard to your actions or conduct at the event. The Event Organizers will not publish your information or image without your verbal consent.

You may not record, copy, publicly exhibit, transmit, or distribute any virtual event through any means, resell views of any virtual event, or allow others to log into your account for the purpose of watching a virtual event or accessing information about speakers or other attendees. Doing so will result in legal action, removal from the

event and denial to all future events. See the Event Rules/Code of Conduct for more information.

## **17. You Are Subject to Search & Identification**

You and your belongings will be searched on entry to attendee only event venues, every time. You consent to such searches and waive any related claims that may arise. If you elect not to consent to such searches, you may be denied entry to the event without return or other compensation. Under certain facility rules, certain items may not be brought into the premises, including without limitation: firearms, alcohol, drugs, controlled substances, cameras, recording devices, laser pointers, strobe lights, irritants (e.g., artificial noisemakers), bundles and containers.

Your badge must be worn at all times during the event in attendee only areas. Your identification is verified every time you access these venues. If a person is found to be using another attendee's badge, both persons will be photographed, removed from the event without refund, and blocked from future events.

## **18. Unlawful Resale of Tickets; Promotions**

Unlawful resale (or attempted unlawful resale) of tickets, including but not limited to counterfeit or copy of tickets, is grounds for seizure and cancelation without compensation. Certain maximum resale premiums and restrictions may apply in some states, and we cannot be responsible for providing legal advice regarding resale or pricing of tickets. You are responsible for complying with all applicable ticket resale laws. In addition, we reserve the right to restrict or deny ticket purchasing privileges to anyone that we determine to be, or to have been, in violation of our policies. Because we do not guarantee the authenticity of tickets purchased from any non-authorized third party reseller (such as brokers or individuals), we recommend that you purchase tickets directly through us, through authorized partners, or from the venue box office to ensure ticket authenticity. Tickets may not be used for advertising, promotions, contests, or sweepstakes, unless formal written authorization is given by us.

## **19. Conference Code of Conduct**

All attendees, speakers, sponsors and volunteers at our conference are required to agree with the following code of conduct. Organisers will enforce this code throughout the event. We expect cooperation from all participants to help ensure a safe environment for everybody.

Our conference respects the privacy of all attendees, speakers and Event staff.

Sharing photos, location (tags), tagging individuals in photos, sharing information and other media regarding the event - DURING THE EVENT - is strictly prohibited.

The social media of attendees as well as tags will be monitored and attendees found doing so will be asked to remove such content and/or leave the event immediately, without return or refund.

Our conference is dedicated to providing a harassment-free conference experience for everyone, regardless of gender, gender identity and expression, age, sexual orientation, disability, physical appearance, body size, race, ethnicity, religion (or lack thereof), or technology choices. We do not tolerate harassment of speakers or conference participants in person or online.

Disparaging language and imagery regarding the speakers or Event Organizer is not appropriate for any conference venue, including talks, workshops, parties, Twitter and other online media.

Conference participants violating these rules may be sanctioned or expelled from the conference without a refund at the discretion of the conference organisers.

Harassment includes offensive verbal comments related to gender, gender identity and expression, age, sexual orientation, disability, physical appearance, body size, race, ethnicity, religion, technology choices, sexual images in public spaces, deliberate intimidation, stalking, following, harassing photography or recording, sustained disruption of talks or other events, inappropriate physical contact, and unwelcome sexual attention.

## **PRIVACY POLICY**

The Conference of Masculine Excellence ("Event Organizer", "We" or "Us") respects your privacy and is dedicated to protecting the privacy of those persons ("You") participating in events organized by Event Organizer and using the Event Organizer website and associated services ("Services"). This Privacy Policy helps You to understand what Personal Information (as defined below) and non-personal information We collect, and how We use it.

This Privacy Policy applies to the processing of Personal Information and non-personal information in connection with the Services and You should read this document before using our Services. If You do not agree to the terms of this Privacy Policy, you may not use our Services.

"Personal Information" refers to information, which allows You to be directly or indirectly identified as an individual person. We may also collect "non-personal information" meaning it can't be used to specifically identify anyone.

Non-personal information may also result from removing the personally identifiable parts from Personal Information. We collect and use both types of information and combinations of both types.

### **Processing Personal Information**

Event Organizer will only collect such Personal Information that is relevant for the purposes described in this Privacy Policy.

Event Organizer will process Your Personal Information for the purposes of providing the Services, including organizing the events and facilitating participant networking using the Event Organizer website and the associated services.

Event Organizer will process Your Personal Information to provide customer service and other services at your request, to send You information, including confirmations, invoices, and other communications, as well as communicate with You about promotions and other news about services offered by Event Organizer.

Event Organizer commits to adhere to the applicable laws and regulations pertaining to processing of Personal Information, as well as to process Personal Information in compliance with good processing practices. All Event Organizer' personnel processing Personal Information are obliged to keep such information strictly confidential.

### Legal Basis for the Processing

The applicable legal basis for the processing of Personal Information depends on the circumstances relating to the relevant processing activities, as further described below:

- If the processing of Personal Information is necessary for one or more specific purposes, GDPR art. 6(1)(a) serves as the legal basis for processing operations.
- Performance of a contract. If the processing of Personal Information is necessary for the performance of a contract, such as for providing certain services, to which the data subject is party, GDPR art. 6(1)(b) serves as the legal basis for processing operations. The same applies to such processing operations which are necessary for carrying out pre-contractual measures, for example in the case of inquiries concerning our products or services.

- Legal obligation. If the processing of Personal Information is necessary for complying with a legal obligation, such as for the fulfillment of tax obligations, GDPR art. 6(1)(c) serves as the legal basis for processing operations.
- Vital interests. If the processing of Personal Information is necessary for protecting the vital interests of a natural person, such as if a visitor were injured in our premises and his information would have to be passed on to medical personnel, GDPR art. 6(1)(d) serves as the legal basis for processing operations.
- Legitimate interests. If the processing of Personal Information is necessary for processing operations which are not covered by any of the abovementioned legal grounds, but are deemed permissible for the purposes of the legitimate interests pursued by Us, such as marketing, GDPR art. 6(1)(f) serves as the legal basis for processing operations.

## Information We Collect and Sources of Information

We collect several categories of information:

- Information You give to us,
- Technically gathered information when You use our Services,
- Information from third parties in relation to our service.

We collect information that You give to us, for example when You use our Services. This information may include your name and email. On our website, You are also given the opportunity to subscribe to our newsletter.

Event Organizer also collects non-personal information on Your activities in the Services, such as your Internet Protocol address, and time of Your requests or actions in the website and referring website addresses, hardware type, operating system version, browser type, and language.

Event Organizer retains the Personal Information collected pursuant to this Privacy Policy for the period necessary to fulfil the purposes outlined in this Privacy Policy unless a longer retention period is required or permitted by law. The criteria used to determine the period of storage of Personal Information is

depends on the applicable legal basis for the processing of Personal Information: e.g. where the processing of Personal Information is necessary for the performance of a contract, Event Organizer retains the Personal Information as long as it is necessary for the fulfillment of the contract or the initiation of a contract; or, where the processing of Personal Information is necessary for complying with a legal obligation, Event Organizer retains the Personal Information for the respective statutory retention period; or, where the processing of Personal Information is permissible for the purposes of the legitimate interests pursued by Us, such as marketing, Event Organizer retains the Personal Information as long as it is permitted by law.

Thereafter, if the collected Personal Information is no longer needed for purposes specified in this Privacy Policy, Event Organizer will delete Personal Information in its possession within a reasonable timeframe or render it anonymous, meaning “non-personal information”.

We also use other third-party data analytics service providers in order to improve the Services Event Organizer may use tools from third-party service providers, such as Google Analytics, a web analytics service provided by Google, Inc. (“Google”).

Google Analytics uses “cookies”, which are text files placed on your computer, to help the website analyze how users use the site. The information generated by the cookie about your use of the website (including your IP address) will be transmitted to and stored by Google on servers in the United States. Google will use this information for the purpose of evaluating your use of the website, compiling reports on website activity for website operators and providing other services relating to website activity and internet usage. Google may also transfer this information to third parties where required to do so by law, or where such third parties process the information on Google’s behalf. Google will not associate your IP address with any other data held by Google. You may refuse the use of cookies by selecting the appropriate settings on your browser, however please note that if you do this you may not be able to use the full functionality of this website. By using this website, you consent to the processing of data about you by Google in the manner and for the purposes set out above.

The Google Analytics tracking code implemented on this website supports Display Advertising. Google Analytics for Display Advertising is used on this website in form of Remarketing. Third-party vendors, including Google, will show Event Organizer ads on sites across the internet. We use these features of Google Adwords to target past visitors across the internet or visitors with specific interest profiles based on their internet usage. ### Disclosing and Hosting Information

Event Organizer will not disclose your stored Personal Information to third parties for direct electric marketing (email, text messages) without your consent or except as part of a specific program or feature for which You will have the ability to opt-in or opt-out. You may always opt-out of receiving promotional emails by following the instructions in those emails. If You opt-out, Event Organizer may still send You non-promotional customer information, such as emails about providing the Service or Event Organizer' ongoing business relations.

We use external service providers to provide technical solutions or services for processing stored information and access the stored information by using a technical interface and share your personally information with third-party service providers to the extent that it is reasonably necessary to perform,



improve or maintain the Services. We use third-party service providers, such as e-mail service providers, credit card processors, information analyzers and business intelligence providers. Event Organizer has right to share Personal Information as necessary for the aforementioned service providers to provide their services to Event Organizer. Event Organizer is not liable for the acts and omissions of these third parties. Event Organizer may host the Services in and transfer Personal Information for this purpose to countries outside the European Union or the European Economic Area in accordance with mandatory legislation and this Privacy Policy.

We has right to share non-personal information (such as anonymous usage data, referring / exit pages and URLs, platform types, asset views, number of clicks, etc.) with interested third parties to assist them in understanding the usage patterns for certain content, services, advertisements, promotions, and/or functionality of the Services. In exceptional circumstances Personal Information may be disclosed to third parties if required under any applicable law or regulation or order by competent authorities, or in order to enforce the Terms of Service and to investigate possible infringing use of the Services as well as to guarantee the safety of the Services.

Event Organizer has right to share your information in connection with any venue, security office, merger, sale of our assets, or a financing or acquisition of all or a portion of our business. Aggregate or anonymous information about You may be shared with advertisers, publishers, business partners, and other third parties.

## Protection of Information

The registers will be maintained in external service providers' servers with appropriate safeguards, such as password protection, granting the access to the stored information only to persons working at Event Organizer or Event Organizer partners who are expressly authorized by Event Organizer. The register is protected by appropriate industry standard, technical and organizational safety measures. Although we make good faith efforts to store the information collected on the services in a secure operating environment that is not available to the public, We cannot guarantee the absolute security

of that information during its transmission or its storage on our systems. Event Organizer will post a notice on the Event Organizer website or through the Services in case material security breach that endangers your privacy or Personal Information. Event Organizer may also temporarily shut down a service to protect Personal Information.

## Cookies and Tracking Technologies

A cookie is a string of information or a small text file that a website stores on a visitor's device, and that the visitor's browser or operating system provides to "remember" things about your visit. Event Organizer uses cookies to help it identify and track visitors, their usage of the Services, and their access preferences, improving quality, tailoring recommendations, and developing the Services. The cookies will not enable Event Organizer to access and review information stored on Your computer. In addition to cookies, Event Organizer may use other existing or later developed tracking technologies.

Event Organizer works with third parties who use cookies and other tracking technologies to track the effectiveness of the advertisements that may be placed in the Services.
